Summary:

On February 15, 2022, Harris County Sheriff's Office deputies responded to a Discharge of Firearms call for service. Deputies arrived and positioned themselves on side of the decedent's residence. The decedent exited the residence with family members and deputies began to approach. The decedent retrieved a handgun and began firing at deputies, striking two. Deputies returned gunfire at the decedent, who was struck multiple times and fell to the ground. Paramedics arrived and determined the decedent had no signs of life. Two deputies were transported to Memorial Hermann Hospital with non-life threatening injuries.
