On March 9, 2022, the decedent was assessed in the jail clinic for low blood pressure. Houston Fire Department paramedics responded and transported the decedent to St Joseph Hospital for a higher level of care. On March 13, 2022, the decedent's heart rate and blood pressure dropped and life-saving measures were initiated. At 12:13 p.m., a medical doctor pronounced death.
