Summary:

On March 27, 2022, a detention officer was conducting rounds in a cellblock and discovered the decedent unresponsive. Medical and jail staff responded and transported the decedent to the clinic with ongoing life-saving measures. Houston Fire Department paramedics responded to the clinic and determined the decedent was unresponsive and pulseless. At 4:40 p.m., a clinic medical doctor pronounced his death.
