## Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

### Summary:

Occupants of the vehicle were observed stealing Catalytic Converters. Deputies attempted to stop the vehicle due to this theft. The vehicle failed to stop leading deputies on a short pursuit. The original pursuit was terminated due to the deputy loosing site of the vehicle. A short time later another deputy located the vehicle traveling at a high rate of speed on the Grand Parkway( SH 99). This deputy attempted to stop the vehicle but again the vehicle failed to stop.

The vehicle travelled a short distance before the driver lost control, as he attempted to exit the freeway. The vehicle went off the roadway, rolled and struck a tree. Jeremiah Young and Dacorian Marshall were pronounced deceased at the scene.
