#### Summary:

On May 25, 2022, Harris County Sheriff's Office deputies responded to numerous calls of gunshots. Deputies arrived and observed a deceased male lying in the front yard from gunshot wounds. Deputies heard additional gunshots from within the residence and SWAT personnel responded to the scene. SWAT personnel made entry into the residence and discovered two additional deceased males. Investigators determined the decedent shot and killed the two males and fatally shot himself.
