Summary:

On July 15, 2022 at about 11:28 p.m., the deceased was stopped by Dallas Police while driving a vehicle and ultimately was arrested for DWI. The deceased was taken to Parkland Hospital for a blood draw and then taken to the Dallas County Jail. The deceased was booked into the Dallas County Jail on July 16, 2022 at approximately 2:30 a.m. At about 7:19 a.m., the deceased requested to go to the bathroom and returned short time later. The deceased then began to have seizures and went into cardiac arrest. The deceased was transported to the hospital by ambulance and the medical staff was able to obtain a pulse in the emergency room. The deceased remained in the hospital until the time of his death, which occurred on July 18, 2022 at about 7:43 a.m. The cause of death and toxicology results are pending.
