Summary:

Kyle George Wagner W/M 12/27/2022 was booked into the custody of Travis County S.O. on 8/8/2022 @ 0622 hrs. Wagner identified himself as a narcotic user (Heroin / Methamphetamine) and was placed on withdraw protocols. Wagner was housed on a medical post for medical observations. Wagner was found unresponsive by the post officer at about 1033 hrs on 8/9/2022. Life saving efforts were started and continued by EMS, but were unsuccessful. Wagner was pronounced deceased at 1118 hrs on 8/9/2022.

On 12/27/2022, I, Detective A. Redus #5012, received the Medical Examiner's report ME 22-04795. The Manner of Death is listed as an Accident, and the Cause of Death is listed as "toxic effects of heroin." It is signed by Deputy Medical Examiner Leticia Schuman, MD.
