#### Summary:

On August 25, 2022, jail officers were distributing dinner trays when they were advised an inmate was unresponsive in his bunk. Officers responded, started CPR, and summoned medical staff. Medical staff arrived, continued CPR, and transported the inmate to the clinic. Houston Fire Department paramedics arrived, assumed life-saving measures, and transported the inmate to LBJ Hospital. At 4:51 p.m., a medical doctor pronounced death.
