#### Summary:

On November 13, 2022, an inmate notified an officer the decedent was inside his cell hanging from a sheet. Officers and medical staff arrived and noted a pulse on the decedent. Medical staff transported the decedent to the clinic and called the Houston Fire Department. HFD paramedics arrived, assumed care, and transported the decedent to Ben Taub Hospital. On November 15, 2022, at 4:12 p.m., a medical doctor pronounced death at Ben Taub Hospital.
