# Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

#### Summary:

On July 24, 2018 the Travis County Sheriff's Office had an inmate death in custody. The inmate is identified as Naquan Jamar Carter, BM DOB 05-29-1995, Booking # 17-41419. Inmate Carter was housed at the Travis County Correctional Center located at 3514 Bill Price Road in Del Valle, TX 78617 at the Health Services David Unit, cell 11. At some time between 9:51 A.M. and 9:56 A.M. Corrections Officer Daniel Chisdey #5484 began distributing lunch. When he came to inmate Carter's cell the inmate was laying on the floor near his bed. Officer Chidsey asked inmate Carter if he wanted a meal tray, but did not get a response. Officer Chidsey pressed his stat alarm due to an unresponsive inmate at 9:56 A.M. Several other corrections officers responded to give CPR as well as Medical staff until relieved by Fire and EMS personnel at approximately 10:00 A.M. but were unsuccessful in their efforts to resuscitate inmate Carter. He was pronounced deceased at 10:39 A.M.
