## Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

### Summary:

On Saturday May 12, 2018 at approximately 9:16pm United States Border Patrol arrived at the Starr County Jail located at 100 East 6th Street in Rio Grande City, Starr County, Texas. Border Patrol Agent Flores R#512 delivered to the Starr County Jail custody inmate Munoz, Marco Antonio 12/02/1978 for an overnight stay for a illegal entry. During the booking process Starr County Detention Officers Hector Lopez and Crecencio Galvan had an incident with inmate due to him being combative and non-compliant. Officer Galvan proceeded to attempt to restrain inmate Munoz, in which a scuffle ensued. Inmate Munoz was removed from the booking area and placed in the padded cell at approximately 10:47pm during the night shift, inmate Munoz was checked every 30 minutes. The next day, Sunday May 13, 2018, during the morning shift (beginning at 8:00am), Detention Officers Sammy Marroquin, Jose Galvan and Alex Garcia checked on inmate Munoz as well. After bringing inmates for weekend visitation, Office'rs Garcia and Marroquin proceeded to check on inmate Munoz. Upon checking on inmate Munoz, Officers noticed that he was lying on the floor sideways motionless. Officers Garcia and Marroqiun proceeded to open the door and discovered inmate Munoz to be unresponsive. Officer Marroqiun proceeded to check for vitals, in which none were found. Officer Garcia notified shift supervisor Evelario Garza of the situation.

Central Control immediately advised the Starr County Communications to contact Starr County Memorial Hospital EMS. Starr County Jail Command Staff was notified and EMS arrived at location. Starr County Paramedics determined that inmate Munoz had no vitals and was deceased. Starr County

Jail Command Staff Chief Jose R. Molina, Captain Juan R. Rodriguez and Lieutenant Brenda Perez reviewed padded cell camera and observed that inmate Munoz had taken off his sweater and used his sleeves to tie them around the steal grate on the floor used for the drain making a loop. Inmate Munoz then placed his head in the loop causing the sweater to be wrapped around his neck. Inmate Munoz then began to turn his body in a clockwise motion several times, causing himself to impede his breathe and circulation until he could no longer do so. Starr County Patrol Sergeant Gerardo Gonzalez arrived at location and took preliminary report. Texas Department of Public Safety Ranger Reed Rackety arrived at location and took over the investigation.
