Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

Officer was checking the area for a vehicle and suspect matching the description of an individual involved in two incidents (aggravated robbery and attempted aggravated robbery) a few minutes prior. Office observed the vehicle parked and unattended in a convenience store parking lot. As the officer approached the store observed an individual matching the description inside the store. The officer announced over the radio that he located an individual matching the description inside the store and the individual had a knife and requested additional units. The individual was walking toward the door and the officer step inside the door and immediately began ordering the individual to stop. The individual failed to comply and continued toward the officer. Additionally, the individual displayed a knife and was yelling at the officer. The officer informed the individual multiple times to get on the ground. The individual failed to comply and charged at the officer. The officer discharged his firearm stopping the individual from continuing to charge him.
