Summary:

On January 14, 2020, at approximately 1020 hours, officers were dispatched a "Traffic Hazard/Person on the Road" call at 13500 Gulf Frwy. Several calls were received regarding a white male walking on the freeway near moving lanes of traffic and crossing over the center barrier near the HOV lane. Officers arrived and noticed that the male appeared to be under the influence of an unknown substance. A struggle ensued, during which the suspect attempted to grab an officer's gun . Officers attempted to detain the male and were able to handcuff the male. The male became unresponsive and officers immediately administered Narcan and began CPR. The male was transported to Memorial Southwest Hospital by the Houston Fire Department, where he was pronounced dead.
