Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

Officers observed a stolen vehicle and attempted to perform a traffic stop on the vehicle. A vehicle pursuit ensued, driven by the deceased. The occupants of the vehicle later abandoned it and ran on foot. A short time later, Jasman Washington, the driver of the original stolen vehicle, robbed (carjacked) a citizen of their vehicle. The citizen sustained minor injuries in her attempt to prevent the theft.

Officers with multiple agencies engaged in a second vehicle pursuit with Washington. Washington lost control of the vehicle in the area of 1600 East Regis Street. Multiple officers attempted to contain the vehicle driven by Washington using their police vehicles.

Washington attempted to break the vehicle containment by ramming the police vehicles surrounding him.

Washington violently struck the vehicles in an attempt to flee. Washington sharply turned the wheel of the vehicle and accelerated so that he drove directly at an officer. Washington used the stolen vehicle as weapon striking and knocking the officer backwards.

Multiple officers on-scene fired their weapons at Washington in an attempt to stop the ongoing and immediate threat to their safety. Washington was hit multiple times and was pronounced dead on-scene
