Summary of Incident

Summary of How the Death Occurred: (max. 30,000 characters)

Summary:

On June 21, 2020 at approximately 11:19 a.m., Dallas County Sheriff's Department Detention Service Officer (DSO) D. Hernandez #9390 entered inmate housing location KT-1I on the 1st floor of the Suzanne Kays Jail in the Lew Sterrett Justice Center located at 111 W. Commerce Street Dallas, Dallas County, Texas 75207 and relieved Dallas County Sheriff's Department DSO M. Mosley #9311 for a lunch break. DSO Hernandez began passing out lunch trays to the Dallas County Jail inmates for feeding. Dallas County Jail inmate Vincent Blair Bone W/M 02/27/1996 book-in #20019387, along with several other inmates attempted to wake up Dallas County Jail inmate Channel Lee Greer B/M 08/12/1956 book-in #20013749 for lunch, but Greer was unresponsive.

At approximately 11:30 a.m., DSO Hernandez radioed for Parkland Jail Health medical staff and a supervisor to respond to KT-1I. DSO Hernandez stopped feeding and responded to Greer's bunk, 50. DSO Hernandez called Greer's name and used a handheld portable radio to nudge Greer's leg in an attempt to get a response from Greer, but Greer was unresponsive.

At approximately 11:32 a.m., Dallas County Sheriff's Detention Service Supervisor (DSS) S. Mack #6910 and DSO D. Bell #9368 responded to KT-1I. DSO Bell immediately began Cardiopulmonary Resuscitation (CPR) on Greer. DSS Mack and DSO Bell alternated administering CPR until Parkland Jail Health medical staff arrived.

At approximately 11:33 a.m., Parkland Jail Health medical staff Registered Nurses (RN) Candace Primous, Oluchi Onebunne, Eleni Desissa, and Licensed Vocational Nurses (LVN) Marcus Davis, Sam Okudah, and Jennifer Thomas responded to KT-1I and took over administering CPR on Greer.

At approximately 11:52 a.m., Paramedic Hannah Lukken and Emergency Medical Technician (EMT) Zachery Little with Acadian Emergency Medical Services Unit 943 responded to KT-1I. Paramedic Lukken contacted Parkland Memorial Hospital (PMH) BioTel by telephone and spoke with PMH Emergency Room (ER) Physician Angelia Gardner. PMH ER Physician Gardner instructed Paramedic Lukken over the telephone to continue chest compressions on Greer for an additional twenty minutes. Parkland Jail Health medical staff continued chest compressions until they were instructed to discontinue chest compressions by PMH ER Physician Gardner over the telephone.

At approximately 12:17 p.m., PHM ER Physician Gardner pronounced Greer deceased over the telephone.

At approximately 12:40 p.m., Paramedic Lukken contacted the Dallas County Medical Examiner's Office and spoke with Field Agent Kimberly Anderson. Field Agent Kimberly Anderson assigned IFS #20-11300 for Greer. Field Agent Kimberly Anderson authorized Acadian Unit 943 to transport Greer to the Dallas County Medical Examiner's Office. At approximately 2:54 p.m., Acadian Unit #943 escorted Greer out of KT-11, and transported Greer to the Dallas County Medical Examiner's Office. On June 22nd 2020, an external examination was performed by the Dallas County Medical Examiner's Office. The results of the examination are currently pending. The lead investigation agency is the Dallas County District Attorney's Office.

CONCLUSIONS:

Based on the case history and autopsy findings, it is my opinion that Channel Lee Greer, a 63-year-old black male, died as the result of COVID-19. Congestive heart failure, hypertensive and atherosclerotic cardiovascular disease, chronic obstructive pulmonary disease (COPD), and obesity are contributing factors to his death.
